Dear Daniel,

This letter serves to inform you of the outcome of an IFC Rush Infraction Board hearing on September 1st, 2018. The hearing stemmed from an incident on August 25th, 2018. Thank you for your attention to the matter at hand. After reviewing the complaint and your response, the Judicial Committee Rush Infraction Board has found Delta Kappa Epsilon responsible for the following violations:

IFC Recruitment Rules

III. Pre-Orientation

No freshmen are allowed in any fraternity house during the Pre-Orientation period.

DKE hosted a mixer with the MIT women's volleyball team on the night of August 25th, 2018. Freshmen women on the volleyball team attended the mixer. Based upon the available evidence, the hearing board determined that no freshmen men were in attendance. The recruitment rules ban freshmen from being in fraternity houses, and do not differentiate between men and women. As a result, the hearing board found DKE responsible for violating the rule in question.

Accordingly, the hearing board determined the following appropriate sanction:

1. Delta Kappa Epsilon must pay a fine of \$200 to the IFC.

While hosting freshmen women during pre-orientation is a less serious offense than hosting freshmen men, it is still against the recruitment rules. The hearing board assigned this sanction to ensure that DKE understands that their event did break an IFC rule.

Please note that failure to comply with this sanction is grounds for additional Judicial Committee action.

This concludes any Judicial Committee action with regard to this incident. You have until
