Dear Julia and Quentin,

This letter serves to inform you of the outcome of an IFC Judicial Committee hearing from this past Monday, October 1st, 2018. Thank to you and your fraternity members for your attention to the matter at hand. After reviewing the complaint and your response, the Judicial Committee Review Board has found Delta Psi responsible for the following violation:

FSILG Social Event Policy

IV. Management Requirements for House Events with Alcohol

E. Guest List

A complete list of all attendees must be kept for the duration of the event. This list must be updated for arrivals and departures and should be an accurate representation of attendance at all times. A complete guest list must have a full name, a university of origin, and an indication of who is 21 or over. There should be a time entered on the list. Members of the organization who are present for an event must also be signed in on the guest list but do not count against the 350 invitations of an FSILG.

IFC Risk Management Policy

II. Admittance

- A. Each entrance and exit to an event must be monitored by a non-consuming individual.
- E. Those guests who are of legal age and who wish to drink must show proof of age, and then be fitted with a wristband.
- G. All events must be limited to the safe capacity of the event location as described in the FSILG Social Events Policy. An accurate count must be kept as to the number of guests currently in an event.

III. Control of Alcohol

- D. Alcohol should not be served to any individual who does not have a proper wristband, whose hand has been marked as an underage guest, or who is not of the age of 21.

The Review Board determined that, based upon the available evidence, Delta Psi was more likely than not responsible for the charges listed above. In particular, on the night of April 28th, 2018, Delta Psi did not have anyone working the front door from 12:05 to 12:25 AM. For the duration of this period, the front door was unlocked, allowing approximately 10 people to enter the party without checking in. The Review Board also determined that Delta Psi did not use an adequate guest list for the entire party, as the guest list did not include age, school, or time of entry.

As a result of this finding, the Review Board has determined the following to be appropriate sanctions for the specific events in question and Delta Psi's response to the incident. Please note that failure to comply with any of the listed sanctions is grounds for additional Judicial Committee action.

1. Delta Psi must use an adequate guest list at all social events. This guest list must adhere to the FSILG Social Events Policy and include name, university of origin, an indication of who is over 21, and time of entry.
 - a. An RMC will check to be sure this guest list is being used at Delta Psi's next social event.
2. Delta Psi must create a checklist to be used by the risk manager before each social event to ensure Delta Psi is prepared. The checklist should include assigning party duties.
 - a. This checklist must be submitted to the IFC Judicial Committee Chairman, Christopher Mutty, and the Assistant Director of FSILGs, Liz Jason, by October 21st.
3. This outcome letter will remain as a letter to file. The IFC Judicial Committee may consider this letter when deciding on future allegations against Delta Psi within the timespan permitted in the Judicial Committee Bylaws.

The Review Board assigned these sanctions to ensure that Delta Psi is prepared before social events and follows FSILG policies during the events, including maintaining an accurate guest list.

This concludes any Judicial Committee action with regard to this incident. You have until October 11th, 2018 if you wish to appeal this decision. Grounds for appeal may be found in
