Dear Jared,

This letter is to notify you of the resolution of a report submitted by the MIT Police regarding an incident on April 16th, 2018. The incident involved alleged violations of the MIT Mind and Hand Book and FSILG Social Event Policy.

On the day in question, MITPD arrive to Phi Kappa Sigma after receiving a complaint from a neighbor. Officers noted a large gathered outside of Phi Kappa Sigma. This crowd was likely a result of crowds outside other fraternities combined with Phi Kappa Sigma shutting down its registered social event early. Guests leaving formed a large crowd outside of the house, and brothers did not adequately disperse the crowd. The crowd behaved in a disorderly fashion while outside. As a result, the IFC Judicial Committee finds Phi Kappa Sigma responsible for the following violations:

FSILG Social Event Policy

IV. Management Requirements for House Events with Alcohol

A. Guest Management

1. No lines or crowds of individuals are permitted outside the door

MIT Mind and Handbook

II (6). Disorderly Conduct

MIT prohibits disorderly conduct. Disorderly conduct is defined as any unreasonable or reckless conduct by an individual or group that is inherently or potentially unsafe to other persons or to their real or personal property, and/or any behavior that disrupts the peace or interferes with the normal operation of the Institute or Institute-sponsored activities. Disorderly conduct includes making unreasonable noise, disrupting a lawful meeting, obstructing pedestrian or vehicle traffic, or creating a hazardous situation.

This determination will not result in sanctions and will remain solely as a letter to file. The IFC Judicial Committee may consider this letter when deciding on future allegations against Phi
