Dear Connor,

This letter is to notify you of the resolution of a report submitted by the MIT Police regarding an incident on May 17th, 2018. The incident involved alleged violations of the IFC Risk Management Policy and FSILG Social Event Policy.

On the night in question, officers arrived at Sigma Chi for a standard check of a social event at approximately 10:15 PM. Due to a mix-up in the social event registrations, officers believed that the event started at 10:00 PM, even though it was actually scheduled to start at 11:00 PM. Officers saw no brothers at the door when they arrived. After knocking and being let in to the house, officers spoke to an underage woman who was drinking a beer. Although Sigma Chi was not having a social event, there was a minor in possession of alcohol in their house. As a result, Sigma Chi is found responsible for the following charge:

IFC Risk Management Policy

III. Control of Alcohol

D. Alcohol should not be served to any individual who does not have a proper wristband, whose hand has been marked as an underage guest, or who is not of the age of 21.

This determination will not result in sanctions and will remain solely as a letter to file. The IFC Judicial Committee may consider this letter when deciding on future allegations against Sigma Chi within the timespan permitted in the Judicial Committee Bylaws. While this incident did not happen during a Sigma Chi social event, it reflects poorly on the house as a whole. Sigma Chi is responsible for anything that happens in the fraternity house, and must work to ensure minors are unable to obtain alcohol in the house.
